- Kidkare software program. An Internet software program that allows you to keep all of your monthly records on your computer and then send your claim via e-mail through the Internet.
- We have been in operation since 1984. In-home visits by friendly experienced staff.
- Quarterly newsletters with nutrition news, recipes, food program updates and fun activities.
- Information and fun activity packets, a new one at every visit. We find new ideas to give you at each in-home visit. Fun for you and the children.
- Trainings are held once a year. We offer nutrition information, free materials, new ideas and maybe Stars approved.
- Reimbursement checks are distributed on the last working day of each month. **Direct deposit** is available and payment is guaranteed on time.

## WHAT IS THE CHILD & ADULT CARE FOOD PROGRAM

The Child & Adult Care Food Program is administered by the Office of Superintendent of Public Instruction (OSPI) with funding from the Food & Nutrition Service (FNS), US Department of Agriculture (USDA), which provides a reimbursement for nutritious meals & snacks served in family child care homes. The CACFP plays an important role in the development of healthy eating habits among children birth through 11 years of age enrolled in the program.

### WHO QUALIFIES?

We serve licensed family childcare homes located throughout Washington.

## REQUIREMENTS

What you must do to receive reimbursement each month:

- Maintain your family childcare license.
- Keep daily records of meals served and the children in care.
- Serve meals according to USDA nutrition guidelines.
- Participate in (1) 2 hour Nutrition training each year.
- Have one of our qualified Program Specialists visit you in your home every 4 months, (three times a year).

In exchange for following the guidelines, you will receive a cash reimbursement for 2 meals and 1 snack or 2 snacks and 1 meal per day, per child for each month.

Rates payable for each meal are based on a TIER SYSTEM placed by the federal government effective July 1, 1998.

### TIER I RATES(7/1/23-6/30/24)

BREAKFAST	1.65	Per day, per child
LUNCH/DINNER	3.12	Per day, per child
SNACKS	.93	Per day, per child

Tier I rates are determined by the following guidelines:

1. Provider is located in an area served by any school in which at least 50 percent of the total students enrolled are certified eligible to receive free or reduced priced meals.
2. Provider whose household income meets eligibility guidelines and has been verified.

3. Provider is located in an area based on census data in which at least 50 percent of the children residing in the area are members of households whose income meet the income eligibility guidelines. The income eligibility guidelines are below 185% of the federal income poverty guideline.

### TIER II RATES(7/1/23-6/30/24)

BREAKFAST	.59	Per day, per child
LUNCH/DINNER	1.88	Per day, per child
SNACKS	.25	Per day, per child

A tier II family child care home is one that does not meet the criterion set forth for a Tier I home.

The provider may choose to become a mixed Tier II home by asking the parents of the children in care to submit an income eligibility form to the office. If the household income meets the guidelines, the provider will be paid the Tier I rates for those children.
